1. Opening Items

- A. Call to Order (Lori Krenisky, President Pro Tempore) at 5:15 p.m.

2. Tax Budget Hearing

The purpose of this hearing is to review the tax budget for the following fiscal year 2027. The tax budget provides justification for tax levies to support the operations of the District. The tax budget also provides the County Auditor the "Other Sources of Revenue" for the following fiscal year 2027.

The revenues and expenditures listed in the tax budget for the following fiscal year 2027 are from the Board approved five year forecast for the General Fund and projected revenue for the Permanent Improvement Fund based on historical collections and the County Auditor Schedule A. This is the projected spending plan of the District for next school year. However, the tax budget does not provide any spending authority. Spending authority is established through the appropriations of the District.

This tax budget hearing allows community input prior to the adoption of the budget.

Approval of the tax budget will be considered during the Organizational Meeting to follow.




