## Treasurer Report

Cheryl reported that the current bank balance was \$15,887. Changes to the financials since the last meeting were an expense for \$100 for the top sellers' prize of \$50 each for selling the most raffle tickets. Other additional expenses were for senior banner reprints, coaches' gifts, and misc. supplies. Senior night was budgeted for \$1500 but actual expenses were only \$1,089. There was some additional income from concessions bringing the total net income to \$1,830.

## Nomination/Election of Booster Board Officers for 2019-20

Bryan Mokwa stated that Cheryl Paynter did not want to continue in the Treasurer position for the upcoming year, so all four positions are open for nomination.

Bryan asked for any nominations for the position of Treasurer. There were no nominations presented, therefore the Treasurer position will remain open until the position is filled. Cheryl Paynter agreed to stay in the position until a new Treasurer was appointed.

Bryan asked for nominations for the position of Secretary. M.E. Shambaugh nominated Bridgette Mauter for the position of Secretary. Susie Partin seconded the nomination. Bridgette Mauter accepted the nomination and the nomination was unanimously approved.

Bryan asked for nominations for the position of Vice President. M.E. Shambaugh nominated Bill Kanchok for the position of Vice President. Susie Partin seconded the nomination. William Kanchok accepted the nomination and the nomination was unanimously approved.

Bryan asked for nominations for the position of President. Bridgette nominated M.E. Shambaugh and Susie Partin for the positions of Co-Presidents. William Kanchok seconded the nomination. M.E. Shambaugh and Susie Partin accepted the nomination and the nomination was unanimously approved.

Keith welcomed the new officers to the board.

## Other Business

Keith reported that the athletic director is in the process of pursuing candidates for the open girls' soccer coach position and plans to have a coach in place by March.
